**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Lakehurst, County of Ocean, State of New Jersey, as follows:

- **7-27.1 Right Turn Only**. All vehicles shall Only Turn Right at the following intersections. (**Add**)
  - d. From northerly on Lake Street to easterly on Route 70

#### **Severability**

## BOROUGH OF LAKEHURST COUNTY OF OCEAN, STATE OF NEW JERSEY CORRECTIVE ACTION PLAN YEAR END DECEMBER 31, 2010

The following Corrective Action Plan for the Borough of Lakehurst, County of Ocean, and State of New Jersey is in response to all findings and recommendations in the report of audit of December 31, 2010. It includes all State, Federal and general findings.

#### Finding/Condition # 10-02:

Various funds had interfund balances as of December 31.

#### **Recommendation:**

In accordance with the Division of Local Government Service Directives, all interfunds balances should be liquidated as of December 31.

#### **Corrective Action:**

All 2010 interfund balances will be liquidated by December 2011

## Finding/Condition # 10-03:

There were nineteen tickets assigned to officers that were not issued within six months.

#### **Recommendation:**

That all tickets assigned and not issued within six months be recalled.

#### **Corrective Action:**

The Court currently prints a monthly report for each Officer and highlights any tickets that are six months old with a note to return them to the Court.

#### Finding/Condition # 10-04

Change orders were not authorized by the governing body for a construction contract previously awarded

#### **Recommendation:**

That a procedure be implemented to insure that all change orders are authorized by the governing body

#### **Corrective Action:**

Procedures will be implemented by the Municipal Clerk.

## Finding/Condition #10-05

The fixed assets accounting and reporting system was not properly maintained.

#### **Recommendation:**

That periodic physical inventory be taken and reconciled with property records.

#### **Corrective Action:**

In the future all auction items will be reported to the Finance Office for removal from the inventory listing.

## Finding/Condition # 10-6

Several receipts were not deposited within 48 hours

#### **Recommendations:**

All receipts be deposited within 48 hours

# **Corrective Action:**

All receipts will be deposited within 48 hours.

# Finding/Condition # 10-7

Some grant receivable balances were older than two years

#### **Recommendation:**

That all grant receivable be investigated and cancelled if it is determined that the Borough will not receive the funds.

## **Corrective Action:**

All grants are presently under investigation by the Finance Officer.

**WHEREAS**, the Lakewood Township Municipal Utilities Authority has deemed certain items in their inventory to be surplus property, **and**

**WHEREAS,** the Lakewood Municipal Utilities Authority has agreed to convey ownership of the following property to the Borough of Lakehurst by Resolution dated December 6, 2011, **and** 

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Lakehurst, County of Ocean, State of New Jersey as follows:

1. The Mayor and Administrator are authorized to enter into an Agreement with the Lakewood Township Municipal Utilities Authority for the surplus property described below:

One Caterpillar 300 Kw Generator with ancillary equipment
