**2-51.3 Fees for Copies.**

Letter sized pages or smaller	\$ . 05 per page
Legal sized pages or larger	\$ . 07 per page

b. Accident Reports requested other than in person \$5.00 per report

**WHEREAS**, Assembly Bill A-1811 and its companion bill S-959 which is designated as the “New Jersey Public Water Supply Fluoridation Act,” requires the fluoridation of all public community water systems in New Jersey, **and**

**WHEREAS**, the bills if approved, would require the fluoridation of water in all public community water systems within twelve months of the bill’s effective date, **and**

**WHEREAS**, the Mayor and Council oppose these bills due to the fact that fluoride is a very strong chemical which requires warning labels to keep out of reach of children under six years of age for products which contain the chemical, **and**

**WHEREAS**, the cost of treating the water and associated equipment would produce an unfair burden on the taxpayers as this represents another unfunded mandate by the State of New Jersey.

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Borough of Lakehurst, County of Ocean, State of New Jersey hereby oppose the passage of A-1811 and S-959 known as the “New Jersey Public Water Supply Fluoridation Act,” **and**

**BE IT FURTHER RESOLVED** that copies of this resolution be forwarded to Assembly Speaker Sheila Oliver, Senate President Steven Sweeney, and Robert Martin, Commissioner of the New Jersey Department of Environmental Protection.
