COMMITTEE/COUNCIL REPORTS:

Councilwoman Hodges reported that Family Game Night was a success. About 30 people attended, both parents and kids. Mrs. Hodges gave kudos to Eileen Robbins and Maryanne Capasso for setting up, to Jermaine Jackson for getting the food, and to NovaCare representatives for entertaining the children as well as playing games. Mrs. Hodges added next event is Zumba Night, May 15th at the Community Center from 5pm to 8pm.

Councilwoman Busch reported that we will not be able to apply for the grant for forestry this year but are in the process applying for next year. First step is to apply for the Green Community Grant, second is training. Public Works Supervisor Dave Winton will be doing that this May along with one volunteer.

Councilman Lowe reported the Lakehurst Volunteer Fire Company picked up their new firetruck and added he saw it and was impressed with it.

Councilman Davis reported that the Community Garden Committee will be getting together shortly, no set date yet for Grand Opening. Mr. Davis also added that residents who are interested can sign up at Borough Hall.

Mr. Davis also reported planning for the Historical Society's Fourth of July Car Show is under way.

Councilman McCarthy reported that he attended the Board of Education meeting on April 18, 2018. The district's monthly bill as of April 17, 2018 totals \$1,238,723. Mr. McCarthy added in regards to Policy 511, resident/non-resident eligibility, explanation was given by the Superintendent and assistant Superintendent on the district's current enrollment practices, including military and staff along with monitory impact.

Mr. McCarthy also reported 2018/2019 school year contracts to be offered to existing staff members were approved as well as multiple professional development and student fields trips.

Mr. McCarthy added that he, Councilman Oglesby, and the Public Safety Committee had an Office of Emergency Management meeting yesterday where they discussed having an active shooter drill along with the police department. The drill will take place at Lakehurst Elementary School during the summer. Mr. McCarthy added there were also talks about replacing the radios.

Councilman Oglesby added that right now the radio frequency band, 500mhz, is crowded and that there is a national mandate that they go to 700 MHz, with problem being that it can cost anywhere from \$5,000 to \$8,000. Mr. Oglesby added there is a grant that comes from Oyster Creek Nuclear Plant but they are awarding fewer grants as the funding is limited.

COMMENTS FROM PUBLIC:

Michelle Dimeo, 300 Poplar Street, expressed concern about vehicles going over the speed limit down Manapaqua Street. She had asked if we can lower the speed limit or put more police officers on the street to deter the vehicles from speeding.

Councilman Oglesby responded that the Mayor and Council have voiced their concerns to the County in the past regarding this issue and added the County, in response, did a feasibility study and the study came back that there was no need to reduce the speed limit. Mr. Oglesby said it would be best if Mrs. Dimeo and other residents voiced their concerns directly to the County themselves.

Administrator Childers gave names and phone numbers of the people to contact to voice their concerns.

Randy Salas, 208 Church Street, has concern regarding Lakehurst Board of Education and money being spent.

Councilman Oglesby responded that concerns should be addressed to the Board of Education.
