COMMITTEE/COUNCIL REPORTS:

Councilwoman Hodges reported that the first of Youth and Rec's moonlight movies series will be on June 29th at Lake Horicon. The movie that will be shown is "Moana" so bring your beach blanket, or chair, along with bug spray and enjoy the movie.

Council President Oglesby stated that there will a Public Safety meeting, along with other different agencies, at the ESC building on June 27 to discuss the fireworks.

Councilman McCarthy reported the Public Safety Committee had a complaint from the first aid squad about the timing of the fire department's fund raisers. A meeting was held to come to a clear understanding about the fund raisers so both parties can move forward. The fire department will have a report tonight informing the council of their decision.

Mr. McCarthy further reported the he attended the Board of Education meeting last evening. Under the superintendent's report, the Lakehurst Elementary School conducted a survey on how to improve communication between the school and parents. The school received positive feedback with majority of the parents feeling their child is safe and secure and communication is good. Over the summer, the school will be improving their website for better communication.

Mr. McCarthy added the funding for the 3-year-old program has been secured by the state for the upcoming school year.

Mr. McCarthy stated under the business administrator's report, payment of bills in the amount of \$848,219.88 was approved and the school is waiting approval from the county superintendent for the superintendent merit gold payment in the amount of \$3,375.

Mr. McCarthy added that the Board of Education approved shared services with Island Heights for art instruction and a grant application for a safety grant through the New Jersey school insurance group.

Councilman Davis reported a resident approached him about the billboard located in the Domino's plaza. The resident wanted to know if the borough gave permission for an inappropriate billboard.

Mayor Robbins responded the borough gave approval for the billboard but what goes on the billboard the borough has no control.

Municipal Clerk Dugan stated that an ordinance would have to passed if we wanted to limit the subject matter on the billboard.

Administrator Childers asked to send a letter asking if they can more respectful of what goes on the sign.
