Councilwoman Hodges also reported on September 21st at 5:00 p.m. the Youth and Recreation will be hosting Family Game Night.

Gary Lowe reported the Police Department received a new vehicle and added a former police vehicle will be assignee to the Code Enforcement Officer with the vehicle previously utilized by the Code Enforcement Officer to go up for auction.

James Davis reported the Fourth Of July Car Show was a success although the show was down about 25 cars, the money brought in was the same amount as last year.

COMMENTS FROM PUBLIC:

Dona Sinton, 501 Rose Street, stated with recent news reporting about consolidation, are Lakehurst Officials concern with prospect of consolidation.

Council President Oglesby responded that consolidation efforts have been discussed by the state for decades.

Mrs. Sinton complimented Public Works for their immediate attention to a leak on Rose Street that Mrs. Sinton called in to report. She stated that once the leak was repaired the water pressure has improved compared to what it was for the past eight months. Mrs. Sinton stated back in November, while her and her family were on vacation, there was a leak. When she returned home and turned on her water, all the sediments from the repair came in through the faucet and toilet, requiring her to buy a toilet and sink. Mrs. Sinton added that her water pressure was low but when public works came out to check the pressure, they found it to be within the range. For the past eight months her water pressure has been low but thankfully to this most recent leak and repair her water pressure is now back to normal.

Mrs. Sinton had asked if Public Works Personnel could notify the residents who may be affected by the repairs.

Misty Sinkowitz, 613 Poplar Street, stated that she has three copies of a signed agreement between the Lakehurst Volunteer Fire Company and the First Aid regarding fund raisers. She needs the council to look it over and sign all three copies with one copy going to the fire company, one to the first aid and the other to the council.

Mrs. Sinkowitz also asked if there is something that can be done about the trees on the corner of Manapaqua Avenue and Poplar Street and also on the corner of Chestnut Street and Myrtle Street. She added the trees block the view making you pull out onto the road to see if there is oncoming traffic, nearly getting hit.

Borough Administrator Childers responded that we will have the Borough Code Enforcement Officer let the homeowners aware of the issue.
