REVIEW OF REGULAR MEETING AGENDA:

Deputy Municipal Clerk Capasso reviewed regular meeting agenda.

PUBLIC COMMENTS ON AGENDA ITEMS:

Dona Sinton, 501 Rose Street, questioned the Community Center Ordinance.

Borough Attorney Sean Gertner responded that this is not the time for public comments on ordinances not on the consent agenda, adding Mrs. Sinton will get a chance to comment during second reading.

Mrs. Sinton questioned the chicken ordinance with regard to chickens not allowed on duplex properties.

Council President Oglesby responded it depends where the duplex exists.

Councilwoman Busch asked is it because the size of lot the duplex is on.

Mr. Oglesby responded a waiver would need to be obtained.

Mrs. Sinton responded that the ordinance was not clear regarding duplexes or waivers.

Mr. Oglesby stated the ordinance committee will review the matter.

Councilwoman Busch asked if next year we can consider a rain date for the Halloween Parade.

Council President Oglesby responded that it was cancelled due to high winds and rain, adding the Mayor made the call due to safety reasons. Mr. Oglesby added it couldn't be rescheduled for the following weekend due to the Rabies Clinic.

Councilman Davis stated a new roof has been put on the Community Center adding the contractor ran into a few problems but were able to remedy the matters.

Mr. Oglesby reported he attended a seminar called "Turning Tax Liabilities into Assets". Mr. Oglesby added there is an alarming statistic of foreclosures especially in southern New Jersey. Mr. Oglesby further added that its an outreach by Rutgers and Walter Rand Institute and other interested parties applying pressure to state legislators for faster foreclosure process adding it can take as long as six years.

DISCUSSION OF PROPOSED LEASE EXTENSION WITH T-MOBILE FOR CELLULAR ANTENNA LOCATED ON THE WATER TOWER:

Borough Attorney Sean Gertner stated he finalized the lease for T-Mobile's one cellular antenna on the water tower. Mr. Gertner added the effective date of the lease is February

2018 at \$2300 a month compared to \$1700 a month; therefore, the Borough will be reimbursed the difference of \$500 a month along with \$2500 for Borough Attorney's fees. Mr. Gertner also added T-Mobile agreed to contribute towards a bi-annual structure analysis and relocation every five years to allow for maintenance. Mr. Gertner further added he was able to negotiate \$2300 a month with a twenty percent increase every five years.

Mr. Gertner asked to move the agreement for T-Mobile's cellular antenna to the consent agenda.

Councilman Davis stated he has concerns on the ordinance on first reading, the ordinance amending and supplementing animal control. Mr. Davis added the ordinance limits to chickens only and that there have been ducks and fowls in the Borough for many years. Mr. Davis is aware that peacocks do need a special license and that turkeys are quite large but would like the ordinance modified to allow ducks and peafowls.

Council President Oglesby stated there are other sections of the animal ordinance, this one is specific to backyard chickens. Mr. Oglesby asked if it would be acceptable to include the ducks and peafowls in the other sections when it is updated as appose to changing this ordinance. Mr. Oglesby added this ordinance takes effect January 1st.

Municipal Clerk Dugan stated there two meetings in December.

Mr. Davis responded he had no objection for it to be updated with the other section.

Alana Scott, 611 Willow Street, asked, in regards to the chicken ordinance, is there a "Grandfather Clause" for those who already own chickens.

Council President responded there will be an annual permit that is required to be filed adding the chicken advisory board will then inspect the property to ensure it is safe for the chickens as well as safe for humans. Mr. Oglesby further added proof will need to be shown that the owner has been educated on the care of chickens.

Mrs. Scott questioned the legality of requiring training for people who have been raising chickens.

Mr. Oglesby responded that residents who have been raising chickens will still need to obtain training.

Dona Sinton, 501 Rose Street, asked what is the procedure for updating the Borough's ordinances.

Borough Administrator Childers responded the Borough will be codifying existing ordinances after the new year.

Councilwoman Hodges responded the ordinance committee will be looking at all ordinances at the beginning of the year as well.
