Councilman Davis responded he had a lot of support and great people surrounding to keep it going. Mr. Davis thanked Borough Administrator and Public Works for the way the Memorial turned out despite a few setbacks. Mr. Davis stated he would like to hand over the administration of handling the name plaques to the two veterans' group and stay on as the liaisons. Mr. Davis added he would like the names to be added during the ceremonies held on Memorial Day and Veterans' day.

Mr. Davis reported the Annual Car Show is coming along adding it will be another great turnout.

Councilman McCarthy reported at the Board of Education meeting all annual contracts and services were approved. Mr. McCarthy also reported the monthly bills were \$212,709.88 with a balance of \$1,144,660.56 adding the board members continue to vote no on items number four and five, that is certifications of no over expenditures and no account over expenditures that would supply sufficient funds to meet the district financial obligations. Mr. McCarthy further reported he did ask the board members if there was any news on remediation funding and repayment structure adding there is none.

Mr. McCarthy stated the watermain project has begun adding multiple values have been installed along with 600 feet of water mains. Mr. McCarthy also stated the project will last till late July, early August.
