WHEREAS, the State of Emergency is intended to contain the spread of COVID-19 as the number of cases in the State continues to grow; **and**

WHEREAS, Executive Order 103 stated, "This Order shall take effect immediately and shall remain in effect until such time as it is determined by me that an emergency no longer exists" and the State of Emergency has not yet been lifted; and

WHEREAS, the Governing Body of the Borough of Lakehurst wishes to confirm that a State of Emergency currently exists within the Borough of Lakehurst, and is necessary to ensure the continued provision of essential services to our residents during this emergency; **and**

WHEREAS, that the State of Emergency shall exist until it is lifted by the Governor for the State of New Jersey.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Lakehurst, County of Ocean, State of New Jersey, as follows:

- 1. That a State of Emergency currently exists within the Borough of Lakehurst and that the State of Emergency shall exist until the Governor lifts the State of Emergency for the State of New Jersey.
- 2. That this Resolution shall be forwarded to the Chief of Police Matt Kline and the OEM Coordinator, Dan Hourigan.

WHEREAS, due to this pandemic the governing body may be unable to hold or may need to cancel or delay certain public meetings where the payment of bills would normally be authorized by the governing body; **and**

ORDINANCE OF THE BOROUGH OF LAKEHURST, IN THE COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE ACQUISITON OF PORTABLE RESTROOMS AT LAKE HORICON AND TO APPROPRIATE THE SUM OF \$44,400.00 TO PAY THE COST THEREOF, FULLY FUNDED BY THE A RESERVE IN THE GENERAL CAPITAL FUND AND A GRANT

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF LAKEHURST, IN THE COUNTY OF OCEAN, NEW JERSEY (not less than two thirds of all members thereof affirmatively concurring) AS FOLLOWS:

- Section 1. The Borough of Lakehurst, in the County of Ocean, State of New Jersey (the "Borough") is hereby authorized to undertake the Acquisition of Portable Restrooms at Lake Horicon.
- Sections 2. The sum of \$44,400.00 is hereby appropriated to the payment of the cost of the improvements authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be fully funded by a reserve in the General Capital Fund. The sum of \$4,700.00 is hereby appropriated from a reserve in the General Capital Fund and \$39,700.00 from a Community Development Block Grant for the payment of the cost of said purpose.
- Section 3. The period of usefulness of the Improvements referred to in Section 2, within the limitations of the Local Bond Law and according to the reasonable life thereof, is not less than five years.
- Section 4. The capital budget of the Borough of Lakehurst is in agreement with the aforementioned improvements.
- Section 5. The improvements authorized hereby are not current expenses and are general improvements the Borough may lawfully make. No part of the cost of the Improvements authorized hereby has been or shall be specially assessed on any property specially benefited thereby.
- Section 6. All ordinances or parts of ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

Section 7. This bond ordinance shall take effect twenty days after the first publication thereof after final adoption, as provided by the Local Bond Law.
