### COMMITTEE/COUNCIL REPORTS:

Councilwoman Hodges reported the Ordinance Committee is meeting regularly on Wednesday nights adding the ordinance review is ongoing. Mrs. Hodges stated the committee plans on meeting two more times with the hopes of completing the first volume and added that she and Municipal Clerk Capasso will reach out to General Code to see what the process is to have the revisions completed. Mrs. Hodges further stated the committee will begin reviewing the Land Use Ordinances at the beginning of the new year.

Mrs. Hodges tasked Clerk Capasso with requesting the 2022 Budget from all department heads by the November 30th. Mrs. Hodges reported that the Finance Committee will meet the first week of December to review the budgets.

Councilman DiMeo reported the Youth and Recreation Committee will be having their monthly meeting this coming Monday, November 8<sup>th</sup> at 7:00 p.m. at the Community Center.

Council President Oglesby congratulated the "victors" of the election.

Councilman Lowe reported all fire truck inspections have been completed and added the security cameras for both Borough Hall and Lake Horicon have been ordered.

Councilman McCarthy reported there were ten On-Point referrals this past month adding he spoke with the Chief Kline discussing the alarming rate. Mr. McCarthy stated that Chief Kline had also spoken to the Chief Financial Officer and the Finance Committee who have assured him that On-point will be in the Police Department's budget next year.

### **COMMENTS FROM PUBLIC:**

Bruce Margenson, 5 Geneva Road, question the cost of the security cameras.

Mayor Robbins answered the cost of the security cameras at Borough Hall and Lake Horicon are approximately \$14,000.

Mr. Margenson asked if the cameras are infrared.

Councilman Lowe responded in the affirmative.

Mayor Robbins added that he will be meeting with JCP&L next week to discuss the lighting at lake.

Mr. Margenson stated last week when he had visited the lake, the restrooms were closed adding he thought the purpose of having the permanent restrooms was to have them open year-round.

Mayor Robbins responded the bathrooms are to be opened till Veterans' Day adding the restrooms will then be winterized till Memorial Day.

Mr. Margenson asked about the watermain replacement project on Union Avenue adding last year the County said they were going to pave the road this year and it is still has not been completed.

Mayor Robbins answered the watermain project is still being reviewed by the Borough Engineer. Mayor Robbins stated the County will not pave the road until the project is completed adding when the County paves the road, the municipality can not dig the road up for five years. Mayor Robbins also stated that the County did promise they will pave Brown Avenue come this Spring.

Bob Vosseller, Manchester Times Reporter, asked the Mayor and Council if they knew Chief Chinery, the first Police Chief of Lakehurst adding he is working on a story for the paper.

Councilman Davis answered he grew up in Lakehurst when Chief Chinery was the Police Chief adding he went to school with his sons. Mr. Davis stated Chief Chinery was a friend and a mentor to him and had helped him get into law enforcement. Mr. Davis also stated they rode motorcycles together when he retired and was a good human being.

Mr. Margenson stated the Police Department is doing a profile on Chief Chinery and added they have articles on him from back when the Manchester Times was known as the Penny Paper.
