ORDINANCE

“AN ORDINANCE OF THE BOROUGH OF LAKEHURST, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING SECTION 7-20 OF CHAPTER VII ENTITLED TRAFFIC”

2023-22

BE IT ORDAINED by Mayor and Council of the Borough of Lakehurst, County of Ocean, State of New Jersey, as follows:

SECTION 1. Chapter VII, Section 7-20 of the Borough of Lakehurst Ordinance is amended and supplemented creating 7-20.1, which shall read as follows:

§ 7-20.1 Penalty for vehicles over designated weight.

Any persons, firms, partnerships or corporations convicted of violating the provisions of §7-20 shall be subject to a fine of not less than \$100 nor more than \$2,000 or imprisonment in the county jail for a term not exceeding 90 days or by a period of community service not exceeding 90 days. Any person who is subsequently convicted of a violation of §7-20 within one year of a previous violation of the same offense shall be subject to an additional fine as a repeat offender.

SECTION 2. Each section, subsection, sentence, clause and phrase of this Ordinance is declared to be an independent section, subsection, sentence, clause and phrase, and the finding or holding of any such portion of this Ordinance to be unconstitutional, void, or ineffective for any cause, or reason, shall not affect any other portion of this Ordinance.

SECTION 3. This ordinance shall take effect immediately upon final passage and publication as required by law.

All ordinances or parts of ordinances that are in conflict herewith are hereby repealed to the extent of such conflict or inconsistency. If any part of this ordinance shall be held to be invalid, such part shall be deemed to be severable and the invalidity thereof shall not affect the remaining parts of this ordinance.
